This Agreement is made this _____ day of _____, 2017, between _____ ("Client"), and Maryland Packaging, LTD, having its principal place of business at 7030 Troy Hill Drive, Elkridge, Maryland 21075.

In consideration of Client retaining Maryland Packaging to perform Consulting Services for Client, it is agreed as follows:

1. Consulting Fees

Client hereby retains Maryland Packaging and Maryland Packaging hereby agrees to perform consulting services at Maryland Packaging Headquarters. Maryland Packaging will perform these services by appointment only and will bill for these services at a rate of ***\$200 per hour with Min 2 hours***. Client shall make full payment for services at the time of booking the consultation via a credit card.

This Agreement shall commence on the date stated above and shall remain in effect until all obligations under this Agreement have been completed. Either party to this Agreement may terminate this Agreement with or without cause by providing at least 10 days written notice to the other party.

2. Scheduling and Availability

Consulting Services must be scheduled a minimum of 10 days in advance and is only available on Thursdays

2. Warranties by Maryland Packaging

Maryland Packaging represents and warrants to Client that it has the experience and ability to perform the services required by this Agreement; that it will perform said services in a professional, competent and timely manner; that it has the power to enter into and perform this Agreement; and that its performance of this Agreement shall not infringe upon or violate the rights of any third party or violate any federal, provincial or municipal laws.

3. Scope of Consulting Services

In general, the scope of Maryland Packaging Consulting Services is focused on: product concept, ingredients, Standards of Identity, processing, packaging, labeling, & certification, Food Safety Modernization Act (FSMA), HACCP, SQF, food safety training, e.g. ServSafe.

4. Confidentiality

Maryland Packaging recognizes and acknowledges that this Agreement creates a confidential relationship between Maryland Packaging and Client and that information concerning Client's business affairs, customers, vendors, finances, properties, methods of operation, computer programs, documentation, and other such information, whether written, oral, or otherwise, is confidential in nature. All such information concerning Client is hereinafter collectively referred to as "Confidential Information. Maryland Packaging agrees to take all reasonable precautions for the protection of Confidential Information.

5. Non-Disclosure

Maryland Packaging agrees that, except as directed by Client, it will not at any time during or after the term of this Agreement disclose any Confidential Information to any person whatsoever. Maryland Packaging further agrees to bind its employees to the terms and conditions of this Agreement.
